



Anti Litter and Anti Graffiti Awareness Grant 2018

Waterford City & Council invites submissions from community groups, youth groups, schools or other community development organisations based in County Waterford, who are interested in receiving funding for public education and awareness initiatives regarding litter or graffiti.

Is your group planning a project to raise litter awareness in County Waterford?

Or maybe you are planning an anti-graffiti awareness initiative? If so, you may be eligible for a grant towards the cost of the project.

How to apply:

1. The application form for this grant is available from the Environment Section, Waterford City and County Council, Menapia Building, The Mall, Waterford or Civic Offices, Dungarvan, Co. Waterford. Phone No: 0761 10 20 20 or www.waterfordcouncil.ie
2. The grant application form should be completed and returned to the Environment Section for consideration by the closing date 14th March 2018.

Conditions and criteria used in selecting anti-litter and anti-graffiti awareness community initiatives

1. All projects should seek to promote greater public awareness and education in relation to litter and/or graffiti and should have a particular focus on involving schools, youth groups, environmental groups, voluntary groups or community groups.
2. Grants should be used, where possible, to leverage local business co-funding of anti-litter or anti-graffiti education/awareness measures.
3. The maximum grant available in any individual case is 70% of the overall cost of the project, with the balance being met by way of local contribution.
4. Projects that receive funding will be obliged to submit a completion report on their project in 2018 detailing expenditure.

Tá Comhairle Cathrach & Contae Phort Láirge ag lorg aighneachtaí ó ghrúpaí pobal, ó ghrúpaí óige, ó scoileanna nó ó eagraíochtaí forbartha pobail eile lonnaithe i gContae Phort Láirge, a bhfuil suim acu maoiniú a fháil do thionscnaimh oideachais phoiblí agus fheasachta maidir le bruscar nó graifítí.

An bhfuil do ghrúpa ag pleanáil tionscadail chun feasacht ar bhruscar i gContae Phort Láirge a ardú? Nó b'fhéidir go bhfuil tú ag pleanáil tionscnaimh feasachta in aghaidh an ghraifítí? Más amhlaidh, d'fhéadfá a bheith i dteideal deontais i dtreo chostas an tionscadail.

2. Is ceart an fhoirm iarratais a líonadh isteach agus a sheoladh thar n-ais go dtí an Rannóg Comhshaoil i gcomhair bhreithiúnais, faoin dáta deiridh 14 Márta 2018.

Na coinníollacha agus na critéir a úsáidtear chun tionscnaimh pobal d'fheasacht i leith frithbhruscair agus fhrithghraifítí a roghnú

1. Ba cheart do gach tionscadal iarracht a dhéanamh chun níos mó feasachta agus oideachais phoiblí a chur chun cinn maidir le bruscar agus/nó graifítí agus ba cheart fócas áirithe a bheith ar rannpháirtíocht scoileanna, ghrúpaí óige, ghrúpaí comhshaoil, ghrúpaí deonaigh nó ghrúpaí pobail.
2. Ba chóir deontais a úsáid, nuair is féidir, chun comhchistiú a fháil ó ghnóthaí áitiúla do bheartais oideachais / feasachta in aghaidh an bhruscair nó in aghaidh an ghraifítí.
3. Sé an deontas is mó atá le fáil in aon chás faoi leith ná 70% de chostas iomlán an tionscadail, leis an fuíollach ag teacht ó ranníocaíocht áitiúil.

4 Beidh ar thionscadail a fhaigheann maoiniú tuairisc críochnaithe ar a dtionscadal i 2018 a chur faoi

5 Projects should be to a high standard and should aim at establishing or replicating best practice in relation to litter or graffiti education/awareness measures. Please note only applications with education awareness will be considered. The grant is not for structural items, such as street furniture, signs or CCTV cameras etc.

Payment of grants:

1. The applicants will be informed of the outcome in March 2018, regardless of whether their application has been successful or not. If successful a payment of 50 % of the approved grant shall be paid to the name of the Organisation specified on the Grant Application form. Please ensure that this name is the same as the name on the Organisation's bank account.
2. The balance grant of the remaining 50% will be paid following receipt of a completion grant form and evidence of monies spent.
3. The maximum local authority funding for any project is 70% of total cost. The remaining 30% may be time spent on the project, etc
 4. The completion report must be submitted before 1st October.
 5. Please be advised that any grant that remains unclaimed by the 1st October 2018 will be cancelled.

5 Is ceart go mbeidh tionscadail ar ard-chaighdeán agus iad ag díriú ar dhea-chleachtas a chur ar bun nó a athchruthú maidir le beartais d'oideachas nó d'fheasacht i leith bruscair nó graifítí. Tabhair faoi deara, le do thoil nach nglacfar ach amháin le hiarratais a bhfuil oideachas/ feasacht ag baint leo. **Ní** bhaineann an deontas seo le hearraí struchtúrach, ar nós troscán sráide, comharthaí nó ceamaraí CCTV, srl.

Íocaíocht na ndeontas:

1. Cuirfear na hiarratasóirí ar an eolas faoin toradh i mí an Mhárta 2018, is cuma a n-iarrtas a bheith rathúil nó gan a bheith rathúil. Má éiríonn le hiarratasóir deontas a fháil, íocfar 50% den deontas atá ceadaithe in ainm na hEagraíochta mar atá sé luaite ar an bhfoirm iarratais ar dheontas. Déan cinnte de go bhfuil an t-ainm seo mar an gcéanna leis an ainm atá ar chuntas bainc na hEagraíochta.
2. Íocfar an t-iarmhéid 50% den deontas nuair atá an fhoirm ag rá go bhfuil an tionscadal curtha i gcrích agus fianaise den airgead atá caite faighte.
3. Sé 70% den gcostas iomlán uasmhéid an mhaoinithe ón údarás áitiúil d'aon tionscadal. Is féidir am a caithfear ar an tionscadal, srl a bheith san áireamh leis an 30% eile.
4. Caithfí an tuairisc chomhlíonta a bheith curtha isteach faoin 1 Deireadh Fómhair.
5. Tabhair faoi deara go gcuirfear ar ceal aon deontas nach bhfuil éilithe faoin 1 Deireadh Fómhair 2018.
