a. Skills sub-committee

b. S.I.C.A.P

Chief Officer, D. Tuohy updated the members. Waterford Area Partnership has been informed of the 2019 Goal 1 and Goal 2 targets with each target having increased by 5% from 2018. In addition, Substance Misuse has been identified as an emerging need target group for intervention in 2019.

D. Tuohy also proposed that J. Somers replace V. Daly as a member of the LCDC SICAP subcommittee.

The SICAP 2019 plan must be submitted by WAP on IRIS, to Pobal, by November 16th. The LCDC must provide approval in principle at the December 13th meeting. Final approval of the annual plan will take place by February 28th 2019 following approval of the 2018 Annual Performance Review.

As of the meeting with Pobal on October 17th, SICAP Goal one was 71% achieved and Goal 2 was 96% achieved.

6. Launch of the Healthy Waterford Strategic Plan 2018-2021 – December 7th in City Hall

H. Kiely updated the members regarding the launch of the 2018-2021 Healthy Waterford Strategic Plan. This strategy has involved a lot of public consultation and input from the sub-committee members. Good progress is already taking place towards the targets outlined. D. Tuohy reiterated that this launch is an LCDC event and requested a significant attendance from the member noting that Minister Catherine Byrne has confirmed for the event also.

7. SICAP Target Areas 2019

(J. Stokes left the meeting for the following discussion)

Document previously circulated to member detailing the Rural Regeneration Priority areas 2019 that have been identified by the Rural Co-ordination Working Group requiring capacity building and SICAP intervention.

- a. **Cappoquin & Blackwater Development** –Villages identified are Cappoquin, Villierstown, Lismore, Ballyduff Upper, Tallow, Aglish and Clashmore. Based on Pobal Deprivation Index, three villages are disadvantaged i.e. Cappoquin, Tallow and Clashmore with developmental support provided to date by WAP. Agreement with WC&CC and LCDC has deemed it necessary to include other villages to ensure the economic and social regeneration is based on collaborative structures.
- b. **Portlaw** – disadvantaged area under Pobal Deprivation Index. Specific working sub-group of WC&CC, LCDC, WAP and WLP established to determine resources required
- c. **Other rural areas** –Areas not deemed disadvantaged under Pobal Deprivation Index benefit from WAP/SICAP capacity building resources i.e. Passage East, Kill, Cheekpoint & Faithlegg Stradbally and Kinsalebeg. These Rural villages experiencing isolation, no/little economic infrastructure or population decreases etc.

Approval was requested from the members to include these areas in the emerging needs category to enable engagement.


